Key Observations

Strengths:

o High SLA compliance across agencies.

- Transparent corrective actions (refunds, permit issuance, registry updates).
- o Strong collaboration between MDAs.

Challenges:

- o Occasional delays due to incomplete documentation.
- Budget allocation disputes required extended verification.

• Recommendations for 2025:

- 1. Integrate all BEE agencies into a single GRM portal.
- 2. Increased GRM sensitisation for traders investors and other stakeholders.
- 3. Expand **SMS/email alerts** for traders.
- 4. Increase **field monitoring** to reduce unauthorized construction/encroachment.
- 5. Publish quarterly GRM dashboards for public transparency.
