2. Taraba State Fire Service

Applicable to all business premises

Fire Extinguisher Certification	₦1,500 per unit	Optional

3. Taraba State Internal Revenue Service (TSIRS)

Applicable to all registered businesses

Revenue Item	Rate
Business Premises Renewal (Small Business)	₦5,000 per annum
Business Premises Renewal (Medium Business)	₦10,000
Business Premises Renewal (Large Business)	₦25,000
Tax Clearance Certificate (TCC)	₦2,000



4. Taraba State Signage & Advertisement Agency (TASAA)

Applicable to all businesses with signboards or outdoor ads

Revenue Item	Rate
Signage & Advertisement Permit	₦12,000 per annum
Billboard Permit	₦20,000 per sqm
Directional Signage	₦5,000

5. Taraba State Urban Development Board (TSUDB)

Applicable to businesses generating waste or operating in urban areas

Revenue Item	Rate
Waste Disposal Service Charge	₦10,000 per annum
Environmental Sanitation Fee	₦3,000
Premises Environmental Audit	₦2,000

6. Taraba State Environmental Protection Agency

Applicable to businesses generating waste or operating in urban areas

Revenue Item	Rate
Environmental Levy	₦50,000 per annum

6. Ministry of Health

Applicable to applicable to all businesses that provide goods or services

Revenue Item	Rate
Health Inspection & Hygiene Fee	₦10,000 per annum
